Year-End Formulary and Benefit Testing

Claims adjudication errors can result in audit findings, issues of non-compliance, as well as potentially paying fees to health plans for various contractual guarantees. BluePeak can provide an additional level of testing for PBM's to be confident that all CMS requirements are coded correctly for your Medicare customers.

BluePeak has the capability to test multiple formularies and multiple benefits to capture nuances that can vary throughout Medicare plans. Our team of consultants consists of senior level managed care professionals, experienced clinicians and former Centers for Medicare and Medicaid (CMS) regulators who have worked at health plans and pharmacy benefit managers (PBMs) for most of their careers.

Claims Monitoring

In addition to year-end benefit testing, BluePeak can provide ongoing claims monitoring. BluePeak Advisors ensures claims process according to the CMS approved formulary. BluePeak will validate both paid and rejected claims based on the product's formulary status, including tier placement and any formulary restrictions including quantity limits and prior authorizations.

BluePeak's testing includes all four Medicare Part D benefit phases as well as CMS required adjudication logic including new requirements such as:

IRA Changes

- Maximum monthly copays on insulin products
- No enrollee costs applied for adult ACIP vaccines
- Application of the deductible on insulin and ACIP vaccines
- No enrollee cost sharing beyond the TrOOP/Member Out-of-pocket (MOOP) limit

Part E

- Part B copays are paying at the appropriate cost sharing
- Part B products are applying the appropriate pricing

Operational Assessment

Call Center Training
